2024 FINANCIAL YEAR SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 July 2023 – 30 June 2024

Pursuant to the Senate Order for entity contracts the following table sets out contracts entered into by the Regional Investment Corporation which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:

- a) have not been fully performed as of 30 June 2024, and/or
- b) which have been entered into during the 12 months prior to 30 June 2024.

Most of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract. The reasons for including such clauses include:

- a) ordinary commercial prudence that requires protection of trade secrets, proprietary information and the like; and/or
- b) protection of other Regional Investment Corporation or Commonwealth material and personal information.

The accountable authority of the Regional Investment Corporation has assured that the listed contracts do not contain any inappropriate confidentiality provisions.
